

'There will be an effort by the Communist Party of China to infiltrate that capability via cyber, human and hybrid methods using businessmen, engineers and what we call the non-traditional collector. They will go over and above to implement their efforts in that particular technology that's in your district.'" # Gotion allegedly had plans to house 200 to 300 Chinese nationals at a nearby college whose President is helping to facilitate the Gotion plant.

- Chuck Thelen, Gotion Global Vice President, confirmed in conversations with the Big Rapids Township treasurer that the company would bring 200 to 300 Chinese nationals to initiate the start-up of the battery plant. "In an email to the Pioneer, Big Rapids Township treasurer Penny Currie stated that during a meeting in October, she spoke with Gotion Global Vice President Chuck Thelen regarding the question of bringing in Chinese nationals for the initial startup. 'He (Thelen) voluntarily acknowledged the company would bring 200 to 300 Chinese nationals to our area to initiate the startup of the plant, citing that they would have the necessary extensive knowledge to initiate the beginning stages of the plant,' Currie said. 'When asked where these folks would live, he simply stated 'we would build housing for them.' When we questioned where, he ceased talking about the topic.'" - Nearby Ferris State University was proposed as a housing site for the Chinese nationals working for Gotion. "Currie said shortly after the meeting, they were made aware of the suggestion that Ferris State University could house them. When the question was posed to Thelen regarding that possibility, she said, his answer was that FSU would do whatever necessary to partner with Gotion." According to FSU's website, Pink serves as board vice-chair for The Right Place, which facilities economic development deals, including the Gotion plant. FSU might back the Gotion plant because it could drive

additional grants for the university. An FSU memo said a Michigan Economic Development Corporation grant targets shifting Michigan's workforce from internal combustion engines to electric vehicles. The memo said the first-year award would total \$659,500. The memo said the grant would fund a battery production and testing center at FSU. 'First, the center will curate a clearinghouse of expertise to develop the battery production and testing workforce within West Michigan,' the memo said. 'We will share this curriculum with partnering community colleges and sister universities. The center will also focus on applied research areas essential to the safe production of lithium batteries, a key technology for the future of the automotive industry.'" "Thelen said the company will likely have 40-50 employees by year's end in engineering, IT and other positions essential for initial operations. A workforce training partnership with nearby Ferris State University is a key piece of its labor sourcing strategy. The plan also includes bringing 20-50 short-term employees from China to help set the plant up. A general contractor and architect are expected to be named in the next few days." In June 2024, the House committee tasked with investigating China revealed evidence implicating Gotion in "Chinese Communist Party state-sponsored slave labor and the ongoing Uyghur genocide," and called on Biden to ban imports from the companies; Slotkin did not sign on to the effort.

  paramilitary organization that contributes to the Uyghur genocide.

Xinjiang Joinworld appears to maintain strong ties to the PRC's military-industrial complex, as evidenced by its designation as a "National Torch Plan Key High-Tech Enterprise," its ability to secure military-related financing approvals from the CSRC, and its engagement with State Administration of Science, Technology and Industry for National Defense (SASTIND, 国家国防科技工业局) and the XUAR's Defense Science and Technology Industry Office. The company has extensively participated in Chinese national programs with potential military applications, such as the "863" Program, the National Science and Technology Support Program, and the National Science and Technology Major Project, further highlighting its role as a "military supporting enterprise" in high-tech industrialization efforts relevant to the CCP's military modernization goals. <sup>23</sup>

# Michigan leaders raised concerns over the Gotion plant's proximity to a Michigan National Guard camp that has trained Taiwanese military personnel.

- Michigan Congressman John Moolenaar raised concerns that the plant would be built within 100 miles of a Michigan National Guard camp where Taiwanese military personnel have trained. "Michigan Republican Rep. John Moolenaar pointed out the proposed factory would be a mere 100 miles from Camp Grayling, a Michigan National Guard training camp where military personnel from Taiwan have come to train for a possible Chinese attack. "Yet, Michigan's state government leaders are siding with CCP-affiliated companies," Moolenaar said, according to the outlet." - The Gotion plant project will be located within 60 miles of military armories and within 100 miles of Camp Grayling where the Michigan National Guard trains Taiwanese soldiers. - Joseph Cella, the Director of the Michigan-China Economic Review Group, noted that the proposed Gotion plant would be close to a Michigan National Guard armory. "Gotion is owned by Gotion High-Tech, which is owned by Volkswagen and Nanjing Gotion Holding Group Co., Ltd, among other partners. Joseph Cella, director Michigan-China Economic and Security Review Group, told lawmakers on March 15 that Gotion's parent company is headquartered in the People's Republic of China and that its proposed plant would be close to a Michigan National Guard armory."   - Cella said in a testimony that Gotion could be a threat due to its Chinese Communist Party ties and could increase espionage and influence operations by the People's Republic of China. "Cella said in testimony that the Chinese Communist Party controls Gotion. 'The PRC and the CCP are penetrating our shores on a sub-national level and beyond the eyes of the United States Government. This is manifested through industry, higher education and whenever economic engagement occurs, there is great peril to our national security and our state security.... The reports and threats of espionage, intelligence gathering and influence operations by the PRC against the United States government, military, higher education and private sector, have soared in the last 15 years." - Gotion's plant is slated to be built at the Big Rapids Industrial Park. "The relationship with Big Rapids Township is still being built and I have high confidence that very soon, hopefully, they will be included in the overall plans. I do hope, and I do expect and have high confidence, that we will have the relationship with the Big Rapids Township much better cemented. It is just not there yet.' Thelen said he understands there is apprehension about the project and questions that board members feel have not been answered properly, but he believes it will require some de-escalation of the situation to make them feel more comfortable about the project. 'I am going to do my part in that,' he said. 'I am going to have conversations one-on-one with some of the board members and see what is bothering them or what questions they might have and answer them to the best of my ability.' He said they would prefer to have the industrial park property included in the development because that would alleviate some of the wetland mitigation they would have in the Green Charter Township property, making everybody happier.'"
